Whereas, among above, 14 incumbents have either been deceased or retired on superannuation as mentioned against each. However, it has been observed from the records that most of the incumbents had been placed as I/c Deputy Director/Principal (Sr. Scale) during their service tenure; and

Whereas, vide circular No.01-JK(DSD) of 2023 dated 15.06.2023, a tentative seniority in respect of Assistant Directors/ Principal (Jr. Scale)/ Assistant Apprenticeship Advisor circulated among the concerned for inviting objections, if any within 07 days through Director Skill Development J&K, supported by substantial documentary proof; and

Whereas, the department despite of lapse more than 02 months has not received any substantial objection from the Director, Skill Development or from the concerned officers, except a representation made by Mir Nazir Ahmad, retired I/c Deputy Director ITI stating as below:-

"The undersigned was posted as Dy. Director Tech Education Jammu vide Govt. order No. 21 Edu(Tech) of 1994 dated 16.05.1994 in own pay and grade .

Later on sanction to grant of charge allowance for holding the post was accorded vide Govt. order No. 150 –Edu Tech 1996 retrospectively.

The undersigned was accorded the release of grade of Rs. 3000-4500 (pre-revised) Revised scale of Rs. 10000-325-15200 vide Govt. order No. 218-Edu (Tech) of 2000 of 3.7.2000 w.e.f 16.5.1994.

Kindly process my case alongwith other officers after fixing my seniority as per merit for clearance in the grade by DPC/PSC".

Whereas, the grievance/claim of the above retired officer has been examined in light of records and its has been found that vide Govt. order No. 21-Edu(Tech) of 1994 dated 16.05.1994, Mir Nazir Ahmad, Assistant Director was placed as I/c Dy. Director Technical Education Jammu (Erstwhile) in own pay and grade. The charge allowance was also granted to him vide Govt. order No. 150–Edu Tech 1996 dated 05.02.1996 retrospectively and subsequently grade of Rs. 3000-4500 (pre-revised) attached to the post of Deputy Director in Technical Education was also released in his favour vide Govt. order No. 218-Edu (Tech) of 2000 dated 3.7.2000 w.e.f 16.5.1994; and

Whereas, in view of the above circumstance and as per records available in the Department, the incumbent has been incorporated in the final seniority of Assistant Directors/ Principal (Jr. Scale)/ Assistant Apprenticeship Advisor (AAA) at appropriate place so that his claim for clearance/regularization against the post of Deputy Director is considered by the DPC/PSC in light of rules.



