Whereas, while taking comprehensive view on the related court cases, before issuance of final seniority, SLO of the Department observed/opined that there is no any interim/stay order in issuing the seniority list of the superintendent cadre, as of now, as such, the Department may issue the final seniority list with the remarks that the same shall be subject to the outcome of writ petition(s), if any on the subject-matter. However, if the department feels any hesitation in issuing the seniority list under reference, the expert opinion from the department of Law, Justice & Parliamentary Affairs be obtained in the instant case, as the department is presently facing the contempt proceedings in various cases due to pending regularization of the respective cadre for which the updated seniority list is imperative at this stage; and

Whereas, the case file referred to the Department of Law, Justice & Parliamentary Affairs for obtaining legal/expert opinion, who vide U.O No. Law-LIT3/921/2023-10 Dated 20.12.2023 opined/advised as under:-

"Though the matter is sub-judice but there is no stay order regarding finalization/ issuance of the said seniority list. The department can go ahead as per the views expressed by the Senior Law Officer in their file with the condition "Pending outcome of court case, if any,"
