In continuation to Govt. Order No. 35-JK(DSD) of 2020 dated 15-10-2021, In terms of Rule 6 (1) of the Medical attendance-cum- Allowance Rules 1990, sanction is hereby accorded to the re-imburement of Medical expenses to the tune of Rs 21,64,881/- ( Rupees Twenty One lakh Sixty Four Thousand Eight Hundred one only) incurred by Sh. Mushtaq Ahmad Khan work shop Attendant, IT Pulwama for treatment of himself outside the Union Territory at Sri. Ganga Ram Hospital New Delhi w.e.f 22-10-2020 to 03-11-2020 as per referral certificate issued by the Professor and head of Gastroentrology SKIMS Srinagar vide no. SIMS/131/MC-442020/133 dated 02-09-2020. The sanction so accorded is subject to the following conditions;

- 1- Re-imburement of charges shall restricted to items/ procedures admissible under rules for the period of hospitalization.
- 2- All relevant Medical bills/ vouchers shall be got verified and countersigned from competent medical Authority of Hospital where from the treatment has been taken.
- 3- Essentiality certificate on Form-2 issued by the Hospital authorities is obtained and kept on record.
- 4- Follow up, (if any) shall be regulated under rules in vogue.
- 5- An amount of Rs 10.00 lacs which was previously sanctioned and paid in favour of the official vide Govt. Order No. 35-JK(DSD) of 2020 dated 15-10-2020 shall be deducted from the claim.


