Sanction is accorded to the advance drawl of Rs.700.00 LAKH (Rupees Seven Crore only) under CSS "Skill Strengthening for Industrial Value Enhancement (STRIVE)" for its utilization during (2021-22) in favour of Director, Skill Development J&K, and its advance drawl by Accounts Officer, Directorate of Skill Development for further utilization as per the scheme guidelines.

The expenditure shall be made out of these funds subject to the following conditions:-

- I. The expenditure shall be made strictly as according to the classification under which funds have been utilized.
- II. Accounts Officer, Directorate of Skill Development shall vouchsafe the funds.
- III. No diversion of amount shall be allowed under any circumstances.
- IV. UC/Red account shall be furnished to the concerned quarters in time.
- V. There should be uniform expenditure under each object head to avoid rush during last quarter of the financial year strictly according to Appropriation Act 2018
- VI. All codal formalities shall be completed before presentation of bills at treasury.
- VII. The expenditure is monitored meticulously and statement of expenditure be sent to the Administrative Department on monthly basis promptly.
- VIII. All the sanctions/approvals and clearances shall be in place before drawl of money from treasury.
- IX. Expenditure should be made strictly as per the guidelines of the scheme.
