The appointment shall be subject to the following conditions:-

- i) The appointee shall report in the Directorate of Skill Development Department, Jammu/Srinagar (erstwhile Technical Education Department), within a period of 21 days alongwith all original certificates. In case, appointee does not join within stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice;
- ii) the appointee, if already in service / otherwise, shall give an undertaking in the shape of an affidavit to the effect that:-
 - a. If on verification the qualification certificate/ reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake by the concerned issuing authorities, the appointee shall have no claim for appointment and his/her services shall be deemed to have been terminated ab-initio. Further his appointment shall be subject to the final verification of Character and antecedents from the CID in terms of

Government Order No.528-JKGAD of 2021 dated 21.06.2021 as amended from time to time.

- b. The salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates in respect of (ii) (a) above is received;
 - c. The cadre allocated by the appointing authority/SSB shall not be changed under any circumstances by any authority/department /HOD/ Officer.
 - d. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage lateron, he/she shall also be liable for criminal prosecution.
- iv. The appointee shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O No. 192 of 2020 dated 17-06-2020;
 - v. If by any chance candidates who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he/she will be liable for cancellation of selection and criminal prosecution as well in light of the Judgment rendered by the Hon'ble Supreme Court;
 - vi. The inter-se seniority of the appointee shall be as per the merit as it exists in the select list;
 - vii. The appointment shall be subject to outcome of the writ petition/OA, if any pending in any competent court/ Tribunal on the subject; and
 - viii. The appointee shall furnish an undertaking as per the enclosed format.
 - ix. The Director, Skill Development shall allot the post/designation to the appointee on his/her joining as per qualification/requirement.


