Subject:- Termination of Services of Mr. Sakib Ashraf Zargar S/o Sh. Mohammad Ashraf Zargar R/o New Colony Nigeen Hazratbal, Srinagar.

**Government Order No. 11- JK(DSD) of 2022
Dated: 01.02.2022**

Whereas, Mr. Sakib Ashraf Zargar S/o Sh. Mohammad Ashraf Zargar R/o New Colony Nigeen Hazratbal, Srinagar, among others had been appointed as Foreman (Engineering) under Open Merit Category in the Technical Education Department (now Department of Skill Development) vide Government order No. 85-Edu (Tech) of 2013 dated 23.04.2013 on the recommendation of J&K, Public Service Commission conveyed vide communication No. PSC/DR/Foreman/(Engg)/Tech.Edu/2012 dated 07.02.2013 and subsequently posted at Government Polytechnic, Budgam; and

Whereas, he applied for two years study leave for undergoing Masters Degree in Mechanical Engineering outside the country i.e, at North Carolina State University, NC, USA from August, 2015, which did not approved by the Competent authority and Principal, Government Polytechnic, Budgam was accordingly conveyed vide letter No. GPC/Bud/Estt/Pf/2015-16/311 dated 03.09.2015 with the directions to advise the applicant to resume his duties immediately;

Whereas, Mr. Sakib Ashraf Zargar remained absent from duty, therefore, a notice was served upon him at his residential address which stand also published in the Newspaper "Daily Aftab" by the Director, Technical Education, J&K (Now Director Skill Development) vide letter No. DTE/Poly/101/PF/535-38 dated 20.10.2016 impressing upon him to resume his duties with immediate effect; and

Whereas, he failed to do so and final opportunity was given to him by the Administrative Department vide letter No. Edu/Tech/Poly/22/2013 dated 16.03.2018 to resume his duties within a period of seven days failing which action as warranted under Article 128 of J&K, CSR, Volume-I shall be taken against him.



Whereas, Directorate of Skill Development informed that Mr. Sakib Ashraf Zargar has not reported back and remained absent from duties unauthorizably for more than 6 years as on date; and

Now, in terms of Article 128 of J&K Civil Service Regulations Volume-I Mr. Sakib Ashraf Zargar S/o Sh. Mohammad Ashraf Zargar R/o New Colony Nigeen Hazratbal, Srinagar is terminated from the government service with immediate effect and shall not be entitled for any salary/wages from the date he remained absent un-authorizedly i.e, from August, 2015.
