Subject:- Termination of Services of Ms. Sana Iqbal D/o Sh. Fida Iqbal R/o F-25, Govt. Flats, Jawahar Nagar.

**Government Order No. 12- JK(DSD) of 2022
Dated: 01.02.2022**

Whereas, Ms. Sana Iqbal D/o Sh. Fida Iqbal R/o F-25, Govt. Flats, Jawahar Nagar, Srinagar among others had been appointed as Lecturer-I, (Civil Engineering) under Open Merit Category in the Technical Education Department (now Department of Skill Development) vide Government order No. 86-Edu (Tech) of 2013 dated 06.05.2013, on the recommendation of J&K, Public Service Commission conveyed vide communication No. PSC/DR/Lect-I Civil (Engg.)/Tech.Edu/2012 dated 10.01.2013 and subsequently posted at Government Polytechnic, Budgam; and

Whereas, Director Technical Education (Now Skill Development) & Principal Government Polytechnic Budgam vide communication No. DTE/Poly/101/2017/PF/1721-22 dated 29.06.2017 & communication No. GPC-Bud/Estt/2016-17/83 dated 06.06.2017 respectively intimated that she applied for study leave for undergoing two years Masters Degree in Structural Engineering from University of California, USA from August 2016, which did not approved by the Competent Authority; and

Whereas, Principal, Government Polytechnic, Budgam served three notices upon her but despite that, she did not resume her duties; and

Whereas, Ms. Sana Iqbal remained absent from duty since August 2016, therefore, vide communication No.Edu/Tech/Poly/10/2013 dated 18.08.2017 another notice served upon her by the Administrative Department at her residential address by giving last and final opportunity to resume duties within a period of 08 days, failing which action as warranted under Article 128 of J&K, CSR Volume-I shall be taken against her; and

Whereas, she failed to resume her duties despite providing several opportunities from time to time: and



Whereas, Directorate of Skill Development informed that Ms. Sana Iqbal has not reported back and remained absent from duties on unauthorizedly for more than 5 years as on date; and

Now, in terms of Article 128 of J&K Civil Service Regulations Volume-I Ms. Sana Iqbal D/o Sh. Fida Iqbal R/o F-25, Govt. Flats, Jawahar Nagar is terminated from government service with immediate effect and shall not be entitled for any salary/wages from the date she remain absent from duty un-authorizedly i.e, from August, 2016.
