Terms & Conditions of the Committee:-

1. The purchase committee so constituted shall proceed in accordance with the procedures/rules as laid down in General Financial Rules issued by Ministry of Finance Department of Expenditure, GOI and other instructions/orders/guidelines issued by Union Territory of Jammu & Kashmir.
2. Director, Skill Development shall ensure presence of all Principals of those Government Polytechnics for which funds under CSS have been released under M&E Component in each meeting of the purchase committee either in person or through video conferencing. The Principals shall also submit requirement of their respective Polytechnics under M&E Component to DSD.
3. In compelling circumstances, the Principal can depute the senior most faculty member next to him/her to attend the meetings so that M&E as per the requirement of the institution(s) is procured by the Purchase Committee.
4. The committee shall not delegate powers to any subcommittee / individuals to avoid vested interests
