Sanction is accorded to advance drawal of Rs. 350.00 lacs (Rupees Three Crore Fifty Lacs Only) under CSS--"Upgradation of Existing Govt. ITI's into Model ITI's" for establishment of Model ITI at Srinagar by Accounts Officer, Directorate of Skill Development, JKUT, Jammu/Srinagar.

The advance drawal of funds is subject to following conditions:-

- I. The amount shall be utilized after observing all the required codal formalities.
- II. Accounts Officer, Directorate of Skill Development J&K shall vouchsafe the funds and shall ensure that expenditure shall be booked only on the activities which are admissible as per the guidelines of the Scheme and as per approved Action Plan.
- III. The amount shall be credited to the SNA account opened for the Scheme and shall be utilized as per the procedure issued by Department of Expenditure, Ministry of Finance, GoI vide O.M No. F.No. 1(13)/PFMS/2020 dated 23-03-2021 updated from time to time.
- IV. No diversion of amount shall be allowed under any circumstances.
- V. UC/Red account shall be furnished to the concerned quarters in time.
- VI. The expenditure should be made on PFMS Portal strictly as per guidelines of the Scheme and the conditions laid down in the sanction letter of Ministry of Skill Development & Entrepreneurship, Government of India.
