Subject: Release of Grant-in-Aid in favour of Secretary, J&K Board of Technical Education for the financial year 2022-23.

Sanction is accorded to release of Grant-in-Aid of Rs.11.55 lacs (Rupees Eleven Lac Fifty Five Thousand Only) through BEAMS in favour of Secretary, J&K Board of Technical Education with advance drawal by Accounts Officer, Directorate of Skill Development for further placement at the disposal of Secretary, J&K Board of Technical Education for financial year 2022-23.

The Grant-in-Aid so released shall be subject to following conditions:-

- I. Accounts Officer, Directorate of Skill Development shall not draw any fresh Abstract Contingent Bill until a certificate is enclosed from Accountant General (A&E) on the bills that the accounts of previous advance have been rendered to the Accountant General (A&E) as per circular issued by Finance Department under endorsement No. DGAT/PS/DR/T-AdoMisc/42/2021-01/273 dated 12-09-2022.
- II. Secretary, JKBOTE shall ensure immediate compliance to observations of principal Accountant General, J&K regarding JKBOTE accounts during 2018 to 2020 which are of serious nature to prevent financial irregularities and embezzlements in JKBOTE.
- III. The accounts of the institution shall be open to check by the Accountant General, J&K Srinagar/Finance Department as well as the officers of Skill Development Department at any time.
- IV. The audited statement shall be furnished by the Secretary, J&K Board of Technical Education to the Directorate of Skill Development along with monthly account.
- V. The expenditure shall be made on the admissible items only after fulfillment of requisite codal formalities and there should be no diversion of funds in any case.
- VI. Utilization Certificate along with account of expenditure be submitted to the Accountant General, J&K Srinagar/Jammu also.
