Subject:- Speedy disposal of court cases – allotment of work among the officers in Directorate of Skill Development thereof.

**Government Order No:- 27 -JK(DSD) of 2023
Dated: 08.03.2023**

It is hereby ordered that henceforth:-

- i. Joint Director, ITI Jammu/Kashmir are nominated as Nodal Officers and shall be responsible to look after all court cases in their respective divisions. They shall ensure to get all pending replies/objections filled after proper vetting in accordance with procedure prescribed by Law Department under rules in all the court cases and submit weekly outcome reports to this Department by mail with a copy to Director Skill Development.
- ii. Deputy Director ITI (Trainings) shall be the Nodal Officer in the DSD and shall look after all the routine work/ the daily status of filing of replies as per procedure prescribed by the Law Department under rules in contempt as well as all other kind of court cases at Directorate Level in coordination with associate Law Officer of Directorate of Skill Development and shall submit status of all cases on weekly basis to the Administrative Department as well as to the Director Skill Development.
- iii. Ms. Shafqat Ara, I/c Principal Government Polytechnic for Women shall be the Nodal Officer and shall look after and ensure timely action under rules in all the court cases related to Polytechnic Sector in Kashmir Division in addition to her own duties; and Mr. Tabasum Geelani, Lecturer-I MLT shall be the Nodal Officer and shall look after and ensure timely action under rules in all the court cases related to Polytechnic Sector in Jammu Division in the Directorate of Skill Development.
- iv. Further, the following MTS are deployed in the Directorate of Skill Development Jammu/Srinagar as well as Skill Development Mission as indicated against each to deal/assist all the above Officers in the legal section; among them two incumbents shall be assigned to have close liaison with concerned Government Advocate/Counsels at Hon'ble Court, Jammu/Srinagar as well as CAT Jammu/Srinagar for coordinating timely court proceeding and other related works/documents:-


