4. Registrar, IUST shall refund Rs. 10.00 lacs to JKBOTE as advance payment received by IUST from the JKBOTE.
5. Any saving out of the advance drawal occurring due to reduction of number of days/participants keeping in view the actual expenditure in accordance with the admissibility or any other reasons shall be refunded to the Government account.
6. Reasonability / Genuineness of rates shall be ascertained.
7. No diversion of funds shall be made.


