Every year, 35 lac sheep/goats is slaughtered in JKUT for mutton consumption but sheep skins are wasted due to lack of adequate skilled manpower for Leather Industry at Lassipora, Pulwama which can generate tremendous employment for unemployed polytechnic/ITI passouts in JKUT by establishing Leather Processing MSME Units and working as skilled professionals in leather processing industry for production, marketing in the interest of administration and in order to promote skilling of local youth in Leather Technology at Government Polytechnic Shopian, Shri Bilal Ahmad Bhat, HoD Leather Technology already posted at GP Shopian shall enter into MoU with local Leather Industry at Lassipora Industrial Estate located in Pulwama District near Shopian for imparting on "the job training" (OJT) to Leather Technology trade to students at GP Shopian after the trade is introduced at GP Shopian with AICTE approval during current financial year.

For this purpose, one post of HoD, Leather Technology is hereby transferred from Kashmir Government Polytechnic Srinagar to Government Polytechnic, Shopian with immediate effect to promote/introduce Leather Processing/Quality Control trade at Government Polytechnic Shopian.

Shri Bilal Ahmad Bhat, HoD who has been transferred to GP Shopian vide Government Order No. 45-JK(DSD) of 2023 dated 30.04.2023, shall ensure to make an understanding with local industry to establish in industry Estates Lassipora and to encourage students in Leather Technology trade.

Senior most Lecturer in Leather technology shall look after leather Technology Lab/Trade at KGP Srinagar.




