The appointees shall report in the office of Director, Skill Development, J&K, Srinagar within a period of twenty one (21) days from the date of issuance of this order failing which he/she shall forego his/her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates/documents (in original) to be verified subsequently:-

- I. Educational/Technical Qualification issued by the recognized Institute/University valid for employment.
- II. Matriculation/Date of Birth Certificate from recognized Education Board.
- III. Domicile certificate issued by the competent authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Valid relevant category certificate issued by the competent authority, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- a. The appointees shall furnish an undertaking in the shape of an affidavit as per Annexure (A) to this order.

- b. That if the candidates has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile district, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government services. He/She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointees shall not be drawn and disbursed to him/her unless the satisfactory reports in respect of genuineness of qualification/degree certificate/Date of Birth/relevant category certificate is received from the concerned issuing authority.
- d. If on verification, the certificates produced by the appointees proved to be fake or forged, his/her appointment shall stand cancelled ab-initio.
- e. The appointees shall be on probation for a period of two years.
- f. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- g. The inter-se-seniority of the appointees in the J&K Technical Education (Subordinate) Services shall be determined as per the J&K Civil Service (Classification, Control and Appeal) Rules, 1956.
- h. The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
- i. The Character and Antecedent report received from the CID organization through EVS portal is also enclosed.
- j. Their posting/adjustment in the Polytechnic/ITI Sector shall be as per advertisement notification /selection to the post(s) recommended by the J&K SSB.
