Conditions of Appointment:

The appointees shall report to the office of Director, Skill Development, J&K, Srinagar/Jammu and shall be allowed to join duties only upon production of the following original certificates:

1. Educational/Technical Qualification Certificate(s) issued by a recognized Institute/University.
2. Matriculation/Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned District Chief Medical Officer.
5. Valid Category Certificate issued by the competent authority, wherever applicable.

6. Any other certificate required under rules.

The candidates who fail to join within twenty-one (21) days from the date of issuance of appointment order shall forfeit their right to appointment, which shall be deemed to have been cancelled ab-initio, without any further notice.

Further, in case any appointee has availed loan for self-employment from the District Industries Centre (DIC) or District Employment & Counselling Centre of his/her domicile district, the following shall apply:

- The fact shall be ascertained by the Director, Skill Development.
- The appointee shall be required to relinquish the proprietorship/ownership and any stakes in such self-employment unit/enterprise before joining Government service.
- The outstanding loan liability, if any, shall be repaid through suitable EMIs, to be worked out and recovered by the concerned DDO from the salary of the appointee.
- The DDO shall obtain an affidavit from the appointee regarding (a) relinquishment of proprietorship/stakes, and (b) undertaking for repayment of loan.
- The DDO shall also personally monitor the recovery process in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

Additional Conditions:-

1. The appointee shall furnish an undertaking in the shape of an affidavit declaring that he/she has no criminal record and is not facing any criminal proceedings in any court of law.
The salary of the appointee shall not be drawn or disbursed until satisfactory verification of the genuineness of his/her qualification, degree, date of birth, and relevant category certificate(s) from the concerned issuing authority.
3. If any certificate is found to be fake/forged upon verification, the appointment shall stand cancelled ab-initio.
4. The appointment shall be governed by the New Pension Scheme (NPS) in terms of SRO-400 of 2009 dated 24.12.2009.
5. The inter-se seniority of the appointee shall be determined in accordance with the merit secured in the selection list prepared by the J&K Public Service Commission.
